GENERAL CLAUSES

1. Fees.

- The player or legal representative commits to the monthly payment of the corresponding fees, independently of the attendance or not to the activity, while not requesting the corresponding cancellation in writing at the Club office.
- The payment of fees will be carried out monthly at the beginning of each month by direct debit, unless another form of payment is expressly authorized.

2. Cancellation. It is the process that ends the user condition.

- It must be formalized in writing at the reception always before the 20th of the month prior to the one scheduled to be terminated. Once the withdrawal is completed, the user loses all relationship with the Club and all rights regarding the activity.
- **When a player decides to drop out (without being injured or a medical leave), and then wants to register again, for the same course, the mensual quota will be increased by 15%, because the stipulated mensual price is for the anual course.**
- It will be grounds for forced cancellation:
 - The non-payment of fees.
 - Non-compliance with this regulation.

3. Injuries.

- If the player is injured with inability to attend the activity, he/she must immediately inform the club office, providing the medical report, causing the cancellation of the activity at the time of the announcement.
- If the injury is reported in the first half of the month, half of the monthly payment will be charged. In any other case, the entire month will be charged.
- When leaving the school, the reservation of a place in the same group is not guaranteed.

4. Rainy days.

- Because it is an outdoor activity, some classes may be cancelled due to rain without affecting the monthly fee.
- The school management will determine the convenience or not of the cancellation of a class due to rain.

5. Class recovery.

- If possible, the school management will propose a schedule for the recovery of classes cancelled due to rain. The recovery of all of them cannot be guaranteed due to the time incompatibilities of the coaches and the general operation of the school.
- The classes that the student could not attend for personal reasons will not be recoverable in any way.

6. Start and end of the 2018/2019 academic year.

The activities will begin on October 1st and end on June 30th.

7. Late registration.

- If the registration is made during the first half of the month, the entire monthly payment will be paid.
- If the registration is made during the second fortnight, half of the monthly payment will be paid.

8. Festivities.

On festivities there will be no classes. The holidays of the 2019/2020 academic year are:

- 2019: October 9th and 12th, November 1st and December 6th and 25th.
- 2020: January 1st and 6th, March 19th, April 10th and 13th, and May 1st and 24th (Based on previous years, dates may vary upon publication of the 2020 work calendar).

9. Behaviour.

The player must have a respectful attitude towards the coach as well as towards the rest of the classmates, the sports equipment and the facilities of the club. Likewise, swearwords or expressions of bad taste are not allowed.

10. Knowledge and acceptance.

The user, by the fact of formalizing the registration, is obliged to comply with the rules set out herein.
